- All current assessments or records related to exceptional abilities, disability or complex social or emotional needs (if applicable).

**If your child is not an Australian citizen, you will also need to provide:**

- Passport or ImmiCard
- Current visa grant notice for student.

**If your child is a temporary visa holder you will also need to provide:**

- Authority to Enrol or evidence of permission to transfer issued by the International Student Centre (if holding an international full fee student visa, subclass 571P or 500P)
- Evidence of the visa the student has applied for (if the student holds a bridging visa)

**Do parents have to answer all questions?**

Yes, we are required by law to ensure the health and safety of students, staff and visitors on our premises. It is therefore, necessary, for you to answer all questions on the enrolment application form.

The information you provide will assist the school to communicate with you and to care for your child while at school. Should you choose to submit an incomplete form, processing your application may be delayed.

Giving false or misleading information can be a criminal offence in certain circumstances. In the event that statements made in this application later prove to be false or misleading, any decision made as a result of this application may be reversed.

**Why have we asked for information about your occupation and education?**

All Australian education ministers have agreed on the National Goals for Schooling in the 21st Century. The national goals specifically state that the achievement of students in schools should not be affected by discrimination based on sex, language, culture, ethnicity, religion or disability, or by differences arising from social and economic background or geographic location. The goals also state that 'the learning outcomes of educationally disadvantaged students [should] improve and, over time, match those of other students'.

To help us to make sure we are achieving this goal, all parents across Australia, no matter which school their child attends, are being asked to provide information about family background.

The main purpose of collecting this information is to promote an education system which is fair for all Australian students regardless of their background. Providing information about your occupation and education is voluntary but your information will help us to ensure that all students are being well served by Australian schools.
